

**Special Meeting of the Board of Alderman
of the City of Belle, Mo
at the Lonnie Feeler Memorial Building,
104 East Third Street, Belle Mo 65013 on
Monday, June 29th, 2026, at 11:00 a.m.**

- A. CALL TO ORDER: Meeting was called to order at 11:02am and the pledge of allegiance was recited.
- B. ROLL CALL WAS TAKEN: Present were Alderwoman Rebecca Withouse, Alderman Seth Klein, Alderman Steve Vogt, and Alderwoman Jeanette Struempf. Mayor James Mitchell, City Clerk Cindy Barbarick, City Treasurer Charro Reasor, Public Works Supervisor Jim Goben and Public Works Director Darin Guinn and attorney James Klahr by video.
- C. ADDITIONS TO AND APPROVAL OF AGENDA: Motion to approve was made by Alderman Steve Vogt second by Alderwoman Jeanette Struempf with all in favor.

E. New Business

1. Property and Liability Insurance for FY 26/27

A. Mike Clark w/ MGI available to answer questions. Mr. Clark explained that we had a minimal increase this year, that for the first time in several years we have seen it level off. The renewal premium was \$76,701. A motion to approve the 26/27 property and liability insurance was made by Alderwoman Jeanette Struempf seconded by Alderman Steve Vogt with all in favor.

B. Approval to pay first installment and set up ACH reoccurring payments was made by Alderwoman Jeanette Struempf, second by Alderman Seth Klein with all in favor.

2. FY 26/27 Budget Approval -a proposed budget was presented to the council with all departments in balance except Court and Police Department. All departments were discussed. A discussion to remove the property and liability insurance from the court department and distribute that amount among the other departments. To balance the police department, it was suggested to increase the fine revenue. With no other recommendations to the proposed budget, the meeting was placed on recess to allow time for the treasurer to make the adjustments.

At 11:54 a motion to go into recess was made by Alderwoman Rebecca Withouse at seconded by Alderwoman Jeanette Struempf with all in favor.

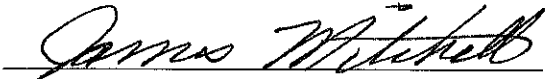
At 12:12 a motion to reopen regular session was made by Alderman Seth Klein second by Alderwoman Rebecca Withouse.

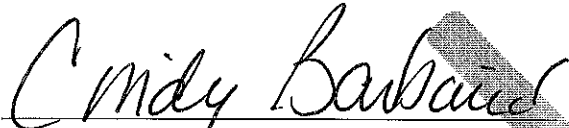
